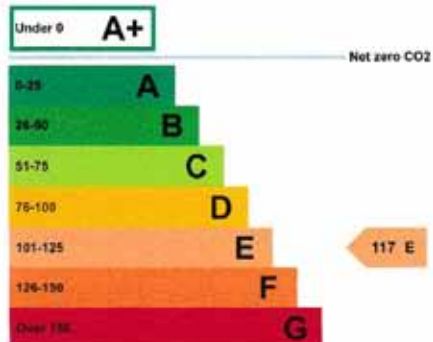
ANTI MONEY LAUNDERING
